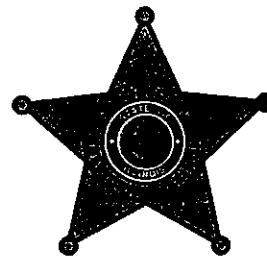

ORDINANCE #

AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN PERSONAL PROPERTY  
(POLICE VEHICLES (SEIZED) / TRAILER AND PUBLIC WORKS TRUCK)

WHEREAS, a Court of competent jurisdiction forfeited an interest in certain motor vehicles which are described in Exhibit A (the Vehicle) and vested title in said vehicle to the City of Belvidere; and

WHEREAS, the City of Belvidere Police Department also is in possession of one 2006 Thor Dutchmen Trailer also described in Exhibit A; and

WHEREAS, the City of Belvidere Public Works Department is in possession of one 1982 Chevy C2500 and one 1991 Volvo WG42 5 yd. dump truck, as identified in Exhibit A which are no longer needed or useful;

Whereas, the Vehicles constitute surplus personal property within the meaning of 65 ILCS 5/11-76-4; and

WHEREAS, the Corporate Authorities of the City find that the previously referenced Vehicles and Trailer are no longer necessary or useful to or in the best interest of the City.

NOW THEREFORE IT IS THEREFORE ORDAINED by the MAYOR and CITY COUNCIL of the City of Belvidere, Boone County Illinois, as follows:

**SECTION 1:** The foregoing recitals are incorporated herein as if fully set forth.

**SECTION 2:** The Mayor, or his designee, is authorized and directed to sell the Vehicles identified in Exhibit A by any means authorized by State Statute, including but not limited to an internet auction site. Further, the Mayor or his designee may elect to separate the box portion of the 1982 C2500 and sell that separately.

**SECTION 3:** If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

**SECTION 4:** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 5:** This Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law which publication is hereby authorized.
